Today's students will become tomorrow's initiators of cultural progress. We believe that a lifelong love of learning and a curiosity to ask deep questions are vital to this process. Our graduates gain clear, independent thinking, empathy, creativity, and ultimately a strength of will to propel them toward moral courage and social responsibility.



Dear Shining Mountain Waldorf School Community,

We continued to successfully navigate the ongoing challenges of the pandemic throughout our school year 2020–2021. The return to in-person learning in September 2020, with COVID health protocols in place, was our absolute priority following the months of remote learning the previous spring. I remain inspired by our community coming together in unprecedented support of our students and programs since the onset of the pandemic. I am also deeply appreciative of the resilience and fortitude of our faculty and staff through many months of challenge and necessary adaptation.

Summer work to prepare for the new school year was extensive in order to return to in-person learning. Considerable planning for outdoor learning spaces and safe indoor classrooms was prioritized to welcome students and faculty back to campus. Program schedules were carefully considered to safeguard class cohorts and teachers, with readiness for any necessary shift to distance learning during the course of the school year.

The exceeding generosity of our school community was evident in the development realm, as our annual fund goal of \$175,000 was far surpassed in a year of critical need due to the impact of the pandemic. The outpouring of love for Shining Mountain and sustaining Waldorf education in financial support given was significant. Additionally, a newly conceived Spring Online Celebration was held in lieu of our annual Gala Fundraiser. The lively virtual gathering was full of warm community connection, good cheer, and generous giving. We are ever grateful to all community members and friends of Shining Mountain who give of their time, talents, and financial support to ensure the sustainable, vibrant future of our school.

In January 2021, Shining Mountain's Board of Trustees called for a re-envisioning of the high school program as a strategic priority. An innovation team, the SMWS Identity Working Group, was formed to develop and carry forth an in-depth, exploratory, and collaborative process leading to the reimagining of Shining Mountain Waldorf High School. A strategic consultant was hired to guide a design and innovation process. This process included extensive constituent interviews and ideation, an external environmental scan, and a trends and data analysis. The process led to several guiding themes and intentions for the high school. These themes, while still formative, have been used to frame the current year's program, goals, and the pedagogical adaptations. Opportunities to expand student interests and knowledge in areas such as social justice, impact science, ethics in business, social entrepreneurship, civics and world affairs, and leadership are part of the emerging high school program. Advanced level classes and an emphasis on student leadership are also in development.

In April 2021, following a number of unexpected delays by the City Planning Board, site review for our campus redevelopment plan was finally passed, both by the planning board and the



Boulder City Council. This significant milestone allowed us to move forward with the next phase of development leading to breaking ground on Shining Meadows for our new high school building in December 2022. Overall, there was a strong sense of support from all involved in the city approval process, even from the few dissenting voices of North Boulder neighbors, who had understandable concerns but felt supportive of Shining Mountain Waldorf School. We are grateful for the leadership of past and current members of our Campus Development Committee, Adrian Sopher and his team at Sopher Sparn Architects, and all of the volunteer community members who have shepherded this project over time.

Our efforts in promoting diversity, equity, and inclusion in our programs and community advanced over the year. We were fortunate to be one of the AWSNA member schools selected to participate in the Spring 2021 School Climate, Equity and Inclusion Survey developed by Panorama Education and the Association of Waldorf Schools of North America. The survey was created to support member schools' DEI efforts by hearing from constituent groups on topics related to school climate, sense of belonging, equity, and inclusion. Additionally, during our February conference week, the faculty, staff, and Board of Trustees engaged in an online training "Beyond Binary: LBGTQ+ Basics and More" with Out Boulder County.

The school year came to a close with such lovely, heartfelt ceremonies and events, especially as we were finally able to include parents and community members in celebration of completing a most challenging year. We graduated a senior class of 21 accomplished students, all distinctly ready to meet the world beyond Shining Mountain. They were well celebrated and honored in closing ceremonies throughout the last week of school.

I offer sincere gratitude to our Board of Trustees for their partnership with me in navigating another extraordinary year. It is my privilege to work closely with this knowledgeable, dedicated, wise, and caring group of individuals carrying forward the strategic priorities of Shining Mountain Waldorf School. I wish to acknowledge the significant contributions of Michael Shaun Conaway, who completed his term as Board President at the end of the school year. I also extend my deep appreciation to Shining Mountain alum, Jordan Jacobsen, for his willingness to lead as our current Board President. Both

Board President's Letter

Students singing outdoors, virtual class play performances, fifth-graders delivering state reports in the late January cold, visits to local farms to milk cows and harvest cabbage, nature walks, a return to our seasonal festivals, an outdoor graduation and Senior Dinner, and much, much more.

This was Shining Mountain during the past school year. Thanks to the hard work of our faculty and staff, when many other schools remained shuttered, our students were mostly on campus, receiving an outstanding education in the middle of the pandemic.

We can all be proud of the way that the Shining Mountain community responded to the protracted and ever-changing challenges of the pandemic. Faculty and staff innovated rapidly to offer outdoor and hybrid education options. Students and their families also were flexible and did their best to find the positive in often difficult circumstances. While these days of COVID-19 may have been a burden to the world, Shining Mountain demonstrated that a strong community can still thrive.

The state of the school's financial health is strong. I am happy to report a fifth consecutive year of positive net income and positive cash flow. We continued our support of faculty and staff with annual raises and bonuses to recognize their extraordinary work during this time.

We also continue to make steady progress on our campus development. In the spring of 2021, we received City of Boulder approval for our land-use application. This is truly a momentous step in our plan to build a new high school, lower school, and a 3,500 square foot addition to the Festival Hall for a performing arts center. This approval also grants the



school the ability to prepare and sell certain lands to help fund the campus development plan.

Our school's success over the past year is in no small part due to the remarkable leadership



of our School Director Mary Fairfield, who leads from the heart with authenticity, grit, and grace. Yet, as she often reminds the Board, she has not accomplished this alone, and her entire team should be commended for their remarkable work this year.

And none of this would have been possible without the support of all of you. We are so proud of the way our entire community has come together during this time of crisis. From Shining Mountain's founding 39 years ago to today, a spirit of giving has characterized our school community.

So on behalf of the Board, faculty and staff, and the students: Thank you everyone! Your generous donations and countless volunteer hours meant our teachers and students had the resources they needed to teach and learn in very challenging circumstances.

The College of Shining Mountain Waldorf School

The College of Shining Mountain Waldorf School is made up of faculty and staff who help foster the mission and impulse of Waldorf education on behalf of the school. The College contributes in a practical way by assisting other leadership groups in the governance of the school through the work of chartered groups and committees, conducting research, ongoing anthroposophically-informed study, and by giving input to the Governance Council and the School Director.

In the 2020/21 school year, the College focused upon strengthening the study aspects of our work. The study of the College and Full Faculty was woven together through the formation of a new Study Planning Group. The SPG (whose members consisted of the Pedagogical Director, College Chair, and Full Faculty Chair) met weekly to plan and prepare the studies for both the College and Full Faculty. The studies focused on DEI and how the Waldorf curriculum does and can further embody the ideals set forth in our school's commitment toward greater Diversity, Equity and Inclusivity. In the spring, the College participated in the interview process of new faculty candidates in addition to focusing on our school identity, as well as a study of the High School section of the Seven Principles of Waldorf Education published by AWSNA. Sandra Kirschner served as the College Chair.

Senior Class of 2021

As with all students the nation over, Shining Mountain's Class of 2021 experienced a unique school year – the continuing global pandemic, social and political unrest, and shifts in the school had their impact on this robust group of 21 students. With these influences also came meaningful senior experiences, deepened relationships with teachers and peers, and opportunities to step into the wider world with greater perspective, empathy, and strength.

These seniors ensouled the high school assembly hall, making it their classroom for the duration of the school year. With the required safety protocols in place, they were only grouped with their class and remained on campus for lunch. Although they did not mix with the other grades, this smaller cohort built windows through which to see and understand their classmates in profound new ways.

Students read and explored universal themes around identity

and society in classic novels such as Orwell's *1984*, Goethe's *Faust*, Thoreau's *Walden*, Emerson's *Self Reliance*, Whitman's *Leaves of Grass*, and Márquez's *100 Years of Solitude* – delving into the 12th grade question, "Who Am I?" They finished the year by performing the play *All in the Timing* by David Ives at Boulder's Spark Theatre, which allowed for a live audience with social distancing. How refreshing it was to have an in-person event again, with parent involvement and faculty attendance!

The Class of 2021 also ventured to the depths of the oceans and the heights of the open sky through their science studies, which included Zoology, Optics, and Astronomy, all to reflect on their unique perspectives and their place in the universe.

In May, they embarked to the desert environment near de Beque, Colorado, where they spent five days immersed in nature (including a 36-hour solo), unmasked, camping on the land,







on a site they chose. This was healing for all who participated.

In June, the seniors had an in-person bell-ringing ceremony with the lower grades, closing the circle with the lower school teachers. The last week of school, under a beautiful white tent on the Lower School playground, we held our senior dinner and graduation. In a year in which social distancing prevented the wider community from seeing their work firsthand, it was a joy to have their self-portraits and stone carvings on display! How wonderful it was to see their expressions and inner self visible through their art. These events included their parents, families and teachers, all ecstatic to celebrate these beautiful 21 students.

2020-21 ANNUAL REPORT

Treasurer's Letter

SUMMARY

The headwinds due to Covid that began during the last fiscal year intensified for this year. We are proud that, despite the challenges, our financial results continue to demonstrate our commitment to financial excellence. Thanks to the hard work and generosity of our entire community, we were able to execute our conservative planning into strong fiscal performance.

FINANCIAL RESULTS

We now are on six consecutive years of achieving both an increase in net assets and a positive operating cash flow. Our assets grew by around \$800,000, with generous contributions from our community playing a big part, as well as the fully forgiven PPP loan that we received last year. These results were more positive than anticipated as we outperformed our budget. We were then able to add another \$100,000 to our Board operating reserves.

Our independent auditor has once again issued an unqualified opinion on our financial statements, which indicates our prudent financial management practices. The auditor was impressed with our internal controls and policies, and also commented on our intelligent use of available cash to reduce our debt expense. donations to enable the campus redevelopment program. We are working with our expert advisors to maximize the value of our land assets to provide funds for both the new high school building and future lower school development and minimize the debt load.

While some of the issues related to Covid have abated, the effects will continue to impact our financials for some time. We are experiencing increased operational expenses and reduced revenues, which is a challenging combination. Similar to last year, we will exercise good judgement to devise a budget suitable for the current situation without inhibiting our ability to support our excellent educational programs now and in the future.

CAMPUS DEVELOPMENT COMMITTEE LETTER

Dear Shining Mountain Community,

This year has shown the collective schools of the Waldorf Movement that we must innovate our schools to meet the children of this time and to serve a world in need of our love and contribution. At SMWS we have sensed this coming moment for the past three to four years. We launched our current campus development efforts and renewed our commitment to sustainability.

In April 2021, Shining Mountain Waldorf School had a public hearing with the City of Boulder Planning Board. This hearing was the result of 14+ months of back and forth with the city on revising our site development plan for the new campus, including the building of a new campus and the sale of a portion of our land. COVID was a big factor in the length of time that it took to go through this process, adding 9 months to the site plan approval.

The Planning Board approved our site plan in four separate votes. This means that for the first time since we started our engagement with the city and county in 2018, we are entitled to develop our property and move forward with our process to get approved plans and building permits.





You can see the layout of the new buildings on our lower school campus, and on the Shining Meadows land, the future home of our new high school. You can also see the approved townhomes at Violet and Broadway and the site of the new high school.

With entitlement, we have moved forward on two fronts. First, we hired the Colorado Group as our commercial land sales agency. They are hard at work on evaluating land value and a marketing plan for the property.

The second front is on technical documentation and then building permits for our new high school. This process usually takes about six months. We are prepared for it to take up to a year considering that these approval steps are taking longer than usual to achieve.

The Board of Trustees is very excited about breaking ground on the new high school.

The plan is for the high school construction to start as soon as we have the building permits to do so. We anticipate that happening by January 2023. Our construction partners at Fransen Pittman assure us that the building will take about twelve months to construct.

In conjunction with the high school project, we plan on starting construction of the Festival Hall performance space addition and then the lower school campus. Our aim is to have the project run as a continuous build to complete the buildings in the shortest viable time possible.

The Board is very appreciative of all those who have worked tirelessly over the past five years to achieve this major milestone with Boulder County.
